## Reports/Updates/Questions/Comments/Clarifications:

<u>Chair Report:</u> (Deanna B.). Deanna B. requested Belinda G. report on the Region 5 Convention and the Region 5 Assembly they attended. Wanda C. (Vice Chair) also attended the Assembly and her report follows.

Region 5's 1st Virtual Convention brought new appreciation, love and inspiration for OA as seen through the Convention's organization, the topics and the speakers. Everyone worked together.

The Virtual Assembly Media Committee reported the print copy of 'Freedom from Bondage' will now be a blog. OA members can submit articles on the Region 5 website. Intergroups shared their success with transitioning from face-to-face meetings to Zoom meetings and few issues with security. Intergroups also discussed dwindling attendance at meetings and Service burnout.

# **Vice Chair Report:** (Wanda C.)

There was a total of 35 people (including 12 visitors) that attended the 3-day Virtual Assembly (10/30 to 11/1). OA volunteers taking responsibility for the Business aspects of running Region 5 was impressive.

Region 5 Standing Rules modified to match language for Zoom Meetings.

Election results: Eileen C. was elected Chair and Linda P. was elected Treasurer. NOTE: NEW ADDRESS forthcoming to send Region 5 donations. Vice Chair is open for the Spring vote.

The Intergroup to Intergroup Subcommittee reported Louisville Intergroup has documents about strengthening Intergroups via a Workshop they are doing in January, 2021.

Motion NOT to have a December Assembly Conference Call passed.

## **Treasurer Report:** (Neal M.)

Only deposits made this period. Insurance payment of \$500.00 due. Proposed 2021 Budget and end-of-year review to be conducted by the Finance Committee (Neal M., Carolyn St. & Deanna B.).

It was suggested that SNI purchase their own Zoom account and budget it for 2021. What other accounts could be explored and what functions could Ring Central bring to Virtual Meetings? These tabled for discussion later.

#### **New Business:**

-Dana C. as Chair of 'The Port Retreat' in Frankfort, Illinois, sponsored by SNI, reported their Committee met 10/25/20. They considered the market overload for Virtual Events and decided to

forego holding the Spring Retreat for March, 2021. The Committee intends to plan another Event for 2022. At this time, they have \$282.00 in operating funds and \$688.00 for scholarships from the prior Port Retreat Committee.

The Committee asked if SNI can hold the above monies until further notice from the Committee. Discussion held about the pros and cons of setting precedents and how supportive/helpful SNI be. Motion made and seconded to decline the request. Voting results indicated unsubstantial unanimity. Further discussion ensued. A Second Motion made and seconded to have SNI hold the money until such time planning begins for the 2022 Retreat. Motion carried. Dana agreed to attach an agreement letter (to the SNI Treasurer) along with the above monies.

-Deanna suggested SNI plan a December (around the 3<sup>rd</sup> week) Recovery Event on Navigating Abstinence around the Holidays to support/inform OA members 'We are not alone'. She also suggested SNI take on 'Projects' rather than engage Committee's since SNI has limited Resources at this time.

Anyone can volunteer to do one or two things. Deanna to invite other people/groups to attend the Zoom planning meeting. SNI Volunteers include Wanda C., Deanna B. to get Speakers, Susan M. (per Deanna) to host/cohost, Carolyn St. to do the Flyer, Maureen R. to develop a format. A Planning Meeting is set for Sunday, November 15<sup>th</sup> at 1:00 PM.
