<u>Vice Chair Report/Acting Chair Report:</u> (Wanda C.) -Four Chicagoland Intergroups will host the 2022 R5 Convention. Although a year away consideration now is whether to convene at a real venue or virtually via zoom. Also, the Committee may consider break-out rooms where people can share.

Treasurer Report: (Neal M.) As of 10/7 there were five (5) deposits of \$450.00 for a total of \$6,464.99 balance. This is the first year SNI has operated at a loss (possibly due to Covid). Income minus expenses yielded a profit of almost \$1,000.00. Taking into account the Website cost of almost \$200.00, the yearly Liability Insurance of \$500.00 there's a profit of about \$300.00. With Expenses for Assembly registration SNI will break about even. The total Bank balance is just shy of \$11,000.00. Excess funds were being distributed to WSO and R5 (i.e. 100% of any profits plus \$1,000.00 to spend down). However, due to the operating loss, it was decided to hold onto the spend down amount until the pandemic was over and stick to the budgeted amount.

UNFINISHED BUSINESS:

Zoom Committee Report: (Penny N. and Maureen R.) The SNI Zoom account would service all SNI Board and Committee Meetings plus Recovery Events. Discussion held about whether or not to purchase more than one account for SNI (one for SNI Business, the other for groups), that SNI could link the Zoom Meeting Lists with the new Website (already considered by AdHoc Committee) and what kind of monitoring that would entail. Penny and Maureen to look into these kinds of possibilities further.

<u>PI/PO Website AdHoc Committee Report:</u> (Carol G. and John C., Webmaster) SNI purchased the Website Domain Basic Plan for 36 months at \$106.00 per month. Domain registration was free. Three additional Security items were added 1.) Domain Privacy, 2.) Code Guard Basis to restore backups and 3.) Sites Lock Security. All for \$189.84. At the end of three years price goes back to normal. The Website was \$190.00 plus \$90.00 per year.

There are Templates for a common theme being looked at from OADenver.org and OAMilwaukee.org. The paperwork for using the OA logo (Carol G.) will be transferred to SNI Chair Wanda C. Laural R. reported the Content is ready to go including the SNI Section on Amends. The next goals are to work on possible Website automatic contributions in the future and for the Winging It Newsletter

2021 ELECTIONS: (Neal M.) The Nominating Committee, Wanda C. (Chair), Maureen R. and Christine G. developed a partial list of willing individuals to stand in nomination for the following positions in today's election. Neal took the nominations for Chair (to fill out the year) as Wanda C., Vice Chair as Carolyn S., and Recording Secretary as Laural R. There was no nominee for Corresponding Secretary. Thus, the position remains vacant. R5 Representatives were Wanda C., Carolyn S. and Christine G. The WSBC Delegate nominee was Wanda C. Neal asked for nominations from the floor which were none. Each nominee answered questions from the floor. The vote was taken via the polling feature on Zoom. Results indicated each candidate (except for Chair) was elected for a two year term.

In October 2022, the Chair and Treasurer positions will be up for election. The Corresponding Secretary position remains vacant and would also be up for election, at that time, if not filled beforehand.
