#### Region 5 Fall Assembly Reports

# Report #1: Carolyn S.

- -Nineteen (19) IG reps in attendance, two (2) guests, and all R5 board members were present.
- -Elections: Vice Chair Kevin F. from Michigan City, Indiana, and Kerri from Central IL was reelected as secretary.
- -Region 4 is disbanding, and Region 5 will be absorbing some of Region 4's Intergroups. The Intergroups have until August 2024 to decide which region to join. It is hoped that Region 5 picks up eight (8) new intergroups.

-Region 5 Spring Assembly will be held in Ohio, March 2024, and the Fall Convention will be held in Ohio September 6-8, 2024.

# **R5 Intergroup-to-Intergroup Committee Report: Carolyn S.**

- -Goal 1 Increase attendance at regional events. Committee members reached out personally to other IG members to encourage attendance. Talking points were developed to assist in listing benefits of attending R5 events.
- -Goal 2 Host Intergroup Renewals One IG is currently in the process, as well as five (5) more slated for 2024.
- -Goal 3 Welcome new IGs from Region 4 R5 looks to add perhaps eight (8) IGs to R5 from Missouri, Iowa, Minnesota, and the remainder of Illinois. Expect participation to begin at Fall Assembly 2024.
- -<u>Decisions made</u>: 1) Provide a welcome pack for each new IG from R4 and others and 2) Update R5 logo including the new states added.
- -<u>Develop and Communicate Digital Best Practices</u> A survey created so each IG can report on what service they use for 7<sup>th</sup> tradition. This survey will be shared with IGs.

#### **R5 Bylaws Committee Report: Carolyn S.**

- -<u>Decisions Made</u>: The Bylaws Committee will be an ad hoc committee without a chair meeting on an asneeded basis to review and discuss tasks. Before the Spring 2024 Assembly, a member will need to act as the Committee Chair to present any motions to the Assembly.
- -<u>Actions Taken</u>: Discussed changing the section of the Bylaws pertaining to Nominations of Trustees. Wrote motion to amend the Bylaws, which will be submitted at the Spring 2024 Assembly.
- -<u>Issues for Later</u>: With the absorption of additional intergroups from Region 4, there will be a need to review the Policies and Procedures manual to evaluate how it may be affected.

#### Report #2: Christine CG.

- -Assembly was held in Edinburgh, Indiana. Twenty-seven (27) individuals attended with representatives from Ohio, Kentucky, Indiana, Northern Illinois, and Wisconsin. Michigan and a portion of Ontario were not represented.
- -Region 4 consisting of Iowa, Missouri, Southern Illinois, Kansas, Nebraska, North and South Dakota is disbanding. R5 Trustee Barb K. made a presentation to Region 4 encouraging Region 4 active groups to consider R5.
- -Barb K. reported WSO has a huge budget gap due to a 40% drop in literature sales, which is WSO's primary source of funding. Members attending virtual meetings often do not take the time to donate. Suggested pausing during the meeting so members can give online.
- -The upcoming Cleveland Convention "Welcome Home, Many Symptoms, One Solution" will be held September 6-8, 2024 in Independence, Ohio. Each IG is asked to decorate a bird house, which will serve as a centerpiece and be raffled off as a fundraiser.

#### Media Committee Report: Christine CG.

- -Focused on obtaining articles for our R5 online newsletter Freedom from Bondage.
- -Committee is evaluating all aspects of the R5 website to restore and check on links making sure the information is correct.

#### PIPO Committee Report: Christine CG.

- -Committee distributed the *Public Information and Professional Outreach Service Manual*, which can also be obtained at <a href="https://www.oa.org">www.oa.org</a>
- -The committee is seeking a chair.

-WSO is developing a pamphlet relating to mental health issues and OA. Input is needed.

#### TSW Fall 2023 Feedback Report (Full report was send out in the SNI Eblast.)

-The event was highly impactful and wonderful. – Everyone loved the venue. The cost was most reasonable. -Suggestion to invest in better nametags. -Poster pickup was not as robust as anticipated.

#### **Intergroup Renewal Goals**

#### Strengthening SNI by Visiting All Our Meeting Groups

-Have 12 groups without representatives. -Continue to make an effort to attend those meetings and encourage the group to have a SNI representative.

#### **TSW Future Event**

- -A few of the suggestions included anything on the steps, encouraging more male attendance by having a male speaker, a traveling event where SNI would take the event to a meeting group, considering a virtual event to boost attendance, develop some type of game that participants would play, i.e.-on the steps. Will discuss more at December SNI Meeting, come with ideas.
- -Wanda C. closed the meeting with a moment of silent reflection for all those who are still suffering from compulsive overeating, then the 7<sup>th</sup> Step Prayer.

If a newly elected chair is currently serving as delegate or representative, that should not keep them from being able to fulfill the duties of SNI chair, which includes being a delegate and a representative.
