 - Susan took the 2 SNI raffle baskets to the Region 5 Convention. The Convention was amazing—full of recovery, inspiration, and fun fellowship.

- Treasurer Carolyn S.
 - The July monthly report and the year-to-date budget report were sent out in the pre-meeting email.
 - Carolyn asked for permission to use SNI funds to purchase Microsoft software with which to fulfill her treasurer duties.
 - Carolyn will consider using QuickBooks or similar software
 - She can Google nonprofit bookkeeping software.
 - Shari would be willing to help her navigate such software.
 - Carolyn will contact the Region 5 Treasurer to learn what they do.
 - There was a deposit from an undisclosed meeting that had closed. We found the meeting (Saturday 8:30 am mtg # 48032).

- Appreciates the great training she received from John C. for managing our website, as well as for the user-friendliness of the design of the website.
- Our website was created in 2021 as an experiment with a 3-year subscription. The renewal due September 19.
- Website John C.
 - Domain, Hosting, Security (to keep the owner of the site is private), Site Security (to prevent hacking) are the four expenses associated with our website.
 - It was decided that John will renew for 1 year to give us time to decide who will be the next owner of the website.
 - John has agreed to change the color and background on the main page each quarter.
 - Carolyn S. will give him credit card information for the renewal.

 - 2 items to consider at a future meeting:
 - Susan suggested we reconsider what we want posted to the Region 5 Intergroup page. (Currently, the region intergroup page refers visitors to see our website for our meeting schedule, newsletter, and intergroup minutes.)

- I added the **spiritual principles** of the Tradition of the month and the Concept of OA Service of the month to the opening ceremonies in the August minutes draft.
- Shari D (our new media coordinator) and I had training on how to post items to the SNI website.
- I updated the **SNI Glossary** and included it in the September pre-SNI eblast.
- Please be thinking of fellows who could be **candidates for SNI** Chair (2-year term), Treasurer (2-year term), Recording Secretary (1-year term), Region 5 Representative (1-year term), and Alternate World Service Business Conference Delegate (2-year term). Check the Bylaws and Policies for qualifications and responsibilities.
- **I have applied** to be a candidate for the Region 5 Chair position. There is at least one other candidate. The Region 5 election will take place at the Region 5 Fall Assembly, November . If I am elected, I will need to step down as Vice Chair of SNI.
- I **enjoy continuing to work** on Region 5 and WSBC committees and subcommittees.
- Region 5 now has started updating the **Intergroup list on region5oa.org**.
