- The Agenda was adopted as written.

- The March 14, 2026 SNI Minutes were adopted as written.

- We discussed the gift basket that SNI donates to the Region 5 Convention each year for which we budget \$125. Members were encouraged to consider what theme we might want to use for this year's basket.
- **Twelfth Step Within Committee:** Susan M. for Paul A.
 - Paul needs to step down as TSW Committee Chair.
 - We would like to find 2 people (with at least 6 months of current abstinence each) to co-chair this committee. These do not need to be representatives.
 - Paul was hoping to have an in-person event in June or September. June is probably too soon to have an event planned and publicized. It was suggested that September is a busy OA month, especially with the Region 5 convention this September. August was suggested as a possibility.

Business:

- **The WSBC motions, nominees, literature** were discussed. Anyone with strong opinions on any of these items which will be voted on at WSBC later this month are encouraged to email Susan M. at susan.m.oe@gmail.com.
- Began a discussion about whether SNI should buy copies of the **Twelve Concepts of OA Service Pamphlet** for our meetings to be used at least partly for their representatives. We discovered that it was available electronically through Amazon Kindle, Apple Books, and Barnes and Noble Nook. The physical and electronic versions of the pamphlet both cost \$3.25. (The short version of the 12 Concepts of OA Service is available in the document library.)
- We ran out of time before could discuss **Bylaws Motion 2**, so it will be put on the agenda for our May meeting.

- The meeting was closed at noon with the Third Step Prayer and the responsibility pledge.

- If you have strong feelings about any of the **proposed motions from the Agenda Questionnaire** (all of which made it to the agenda), please let me know. (If you need to review them, they are also in the Conference e-Documents, 5th and 6th from the bottom of the list.
- The second business item this month is deciding how we can make **the new *Twelve Concepts of OA Service Pamphlet*** available to our voting members.
- The third item is revisiting the **Bylaws motion** that we didn't finish addressing in our March meeting.
